Comment: I'm for evidence based decision making and for strong interrogation of proposals. I'm not for fixed positions on an idea without taking into account the quality/merit of a fully scoped proposal. There will be some precincts in Whitehorse where this makes more sense than others.

In your view, with so many more people walking and cycling, what will be the effect on parks, local streets, traffic and the community generally, and what should Council do about this?

I am expecting more Council consultation and dialogue about pedestrian and cycling infrastructure. I am also an influencer towards holistic context consideration (what's the full picture, if we do one thing in one area what consequences might that have for another community interest, etc). There will also have to be investment choice. Council is in a fixed income situation (with rate capping) and has its own COVID revenue losses to manage. Prioritisation will be the key, my push is that this not be politically or emotively driven. I want it driven by data and social responsibility.

Comment: Budgeting needs a holistic view. I am open to different budget trends, but not because I'm persuaded by the 20:80 ratio without interrogating other considerations. Just because something is more expensive to maintain doesn't necessarily mean it should be reduced in favour of something that requires less infrastructure. I'm more interested in equal access (which is expensive, for example, disability access) than I am in equality of spend across different forms of recreation.
